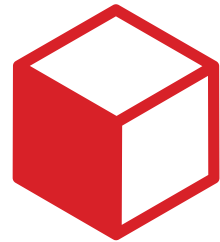

Create remediation plans to address deficiencies found in all 6 audits.

- Have these remediation plans fully documented in writing
- Update and review these plans annually
- All documented plans need to be retained in your records for 6 years

All staff members need to undergo annual HIPAA training.

- Designated staff member as the HIPAA Compliance, Privacy, and Security Officer
- Have documentation of their training

Have Policies and Procedures relevant to the annual HIPAA Privacy, Security, and Breach Notification Rules.

- Have documentation of their legal attestation and for annual reviews of your Policies and Procedures
- Have Business Associate Agreements in place with all Business Associates
- Identify all of your vendors and Business Associates
- Track and review your Business Associate Agreements annually
- Have Confidentiality Agreements with non-Business Associate vendors

Have a defined plan and process for incidents or breaches.

- Make sure to have the ability to track and manage the investigations of all incidents
- Make sure to provide the required reporting of minor or meaningful breaches or incidents
- Staff members have the ability to anonymously report an incident
